AN ORDINANCE CREATING CASUAL POSITIONS UNDER THE ECONOMIC ENTERPRISE DEVELOPMENT DEPARTMENT (EEDD) – MAMBUKAL RESORT AND SANCTUARY OF THE PROVINCE OF NEGROS OCCIDENTAL THEREBY ADOPTING THE REVISED PERSONNEL SCHEDULE OF CASUAL EMPLOYEES AND AUTHORIZING THE GOVERNOR TO AUGMENT THE PERSONNEL SERVICES (PS) COST FROM THE PS SAVINGS OF THE SAID OFFICE

BE IT ENACTED, by the Sangguniang Panlalawigan of Negros Occidental in its Regular Session duly assembled that:

SECTION 1. CREATION. – Two (2) Admin Aide VI (Clerk III), Salary Grade 6, with a monthly salary rate of Seventeen Thousand Five Hundred Fifty Three Pesos (P17,553.00) are hereby created under the Economic Enterprise Development Department (EEDD) – Mambukal Resort and Sanctuary of the Province of Negros Occidental.

SECTION 2. PERSONNEL SCHEDULE. – The Revised Personnel Schedule (LBP Form No. 3) of Casual Employees under the Economic Enterprise Development Department (EEDD) – Mambukal Resort and Sanctuary is hereby adopted, as shown in Annex “A” of this Ordinance.

SECTION 3. AUGMENTATION. – The Governor is hereby authorized to augment the Personal Services (PS) Cost of two (2) created casual positions from the PS Savings from two (2) vacant regular positions under the Economic Enterprise Development Department (EEDD) – Mambukal Resort and Sanctuary pursuant to Section 336 of Republic Act No. 7160, to wit:


