RESOLUTION APPROVING CITY ORDINANCE NO. 2025-07 OF THE CITY OF HIMAMAYLAN REVERTING THE TOTAL AMOUNT OF THIRTEEN MILLION SEVEN HUNDRED THIRTEEN THOUSAND PESOS (P13,713,000.00) ONLY FROM THE FY 2025 ALLOWABLE UNOBLIGATED BALANCES OF PS FOR THE GRANT OF GRATUITY PAY TO QUALIFIED COS AND JO WORKERS FOR FY 2025
