WHEREAS, thereby presented for review and appropriate action of Sangguniang Panlalawigan of Negros Occidental is Resolution No. 2025-062 of the Municipality of Candoni, Negros Occidental, entitled: “RESOLUTION APPROVING THE 03RD SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM FOR FISCAL YEAR 2025 WITH THE PRIORITY PROGRAM/PROJECTS/ACTIVITIES AS EMBODIED IN THE MDC RESOLUTION NO. 05, SERIES OF 2025”;
