RESOLUTION APPROVING RESOLUTION NO. 254-2025 OF THE MUNICIPALITY OF VALLADOLID, NEGROS OCCIDENTAL, ADOPTING THE PEACE AND ORDER PLAN FOR BUDGET YEAR 2026 OF THE SAID MUNICIPALITY IN THE TOTAL AMOUNT OF ONE MILLION NINE HUNDRED FIFTY THOUSAND PESOS (P1,950,000.00)

WHEREAS, thereby presented to the Board for review and appropriate action is Resolution No. 254-2025 of the Municipality of Valladolid, Negros Occidental, adopting the Peace and Order Plan for Budget Year 2026 of the Municipality of Valladolid in the total amount of One Million Nine Hundred Fifty Thousand Pesos (P1,950,000.00);

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Resolution No. 254-2025 of the Municipality of Valladolid, Negros Occidental, subject to the following conditions/recommendation:

1. That the Municipality of Valladolid shall consult with the Department of Interior and Local Government in preparing the required POPS Plan considering that it is a term-based three (3)-year plan that has seven (7) focused areas including that of illegal drugs;
2. That the plans submitted with corresponding resolutions shall be integrated with the POPS Plan and shall be accompanied by an approved Local Development Investment Program (LDIP).
