RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-4 OF THE MUNICIPALITY OF SALVADOR BENEDICTO, NEGROS OCCIDENTAL, COVERING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 3 OF THE SAID MUNICIPALITY IN THE AMOUNT OF SEVEN MILLION FIVE HUNDRED SEVENTY ONE THOUSAND NINE HUNDRED SEVENTY THREE PESOS AND SEVENTY CENTAVOS (P7,571,973.70)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2025 General Fund Supplemental Budget No. 3 of the Municipality of Salvador Benedicto, Negros Occidental with a total appropriation of P7,571,973.70, enacted by the Sanggunian Bayan per Appropriation Ordinance No. 2025-4;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2025-4 of the Municipality of San Enrique covering the 2025 General Fund Supplemental Budget No. 3 of the said municipality with an appropriation of P7,571,973.70 and considered operative in its entirety effective December 25, 2025 subject to the posting requirement under Section 59 of LGC 1991 and subject further to the following conditions:

1. the grant of Service Recognition Incentives (SRI) for FY 2025 must be in accordance with the provisions of Budget Circular No. 2025-3 dated December 15, 2025 of the DBM;
2. the grant of Gratuity Pay to COS and JO workers in government agencies for FY 2025 must be in accordance with the provisions of Budget Circular No. 2025-4 dated December 16, 2025 of the DBM;

RESOLVED FURTHER, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law and that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.

This resolution shall take effect immediately upon approval.
