RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-02 OF THE MUNICIPALITY OF LA CASTELLANA, NEGROS OCCIDENTAL APPROVING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 2 OF THE SAID MUNICIPALITY IN THE AMOUNT OF THREE MILLION NINE HUNDRED FORTY SEVEN THOUSAND SEVENTY SIX PESOS AND SEVENTY EIGHT CENTAVOS (P3,947,076.78)

WHEREAS, thereby presented to the Board for review and appropriate action is the Appropriation Ordinance No. 2025-02 of the Municipality of La Castellana, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 2 of the said municipality in the total amount of Three Million Nine Hundred Forty Seven Thousand Seventy Six Pesos and Seventy Eight Centavos (P3,947,076.78) that was submitted to the Sangguniang Panlalawigan for review on November 28, 2025;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 edition and implementing circulars and other issuances as pre-reviewed and endorsed by the Local Finance Committee through the Provincial Budget Office;

NOW, THEREFORE, on motion of Hon. Rita Angela S. Gatuslao and unanimously seconded by all members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2025-02 of the Municipality of La Castellana, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 2 of the said municipality in the total amount of Three Million Nine Hundred Forty Seven Thousand Seventy Six Pesos and Seventy Eight Centavos (P3,947,076.78) subject to the posting requirement under Section 59 of the Local Government Code and further subject to the following conditions:

1. The appropriation for Donations shall be spent solely for public purpose pursuant to Sections 305 (b), 335 and 351 of the Local Government Code;
2. That Section 56 in relation with Section 326 of the Local Government Code provides that within three (3) days after the approval of the ordinance authorizing annual/supplemental appropriation, the Secretary to the Sanggunian shall forward the said Ordinance to the appropriate reviewing authority.

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with the existing laws, rules and regulations shall be the responsibility of the city government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
