WHEREAS, thereby presented to the Board for review and appropriate action is the FY 2025 Supplemental Budget No. 7 of the Municipality of San Enrique, Negros Occidental with a total appropriation of One Million Seven Hundred Eighty Thousand Pesos (P1,780,000.00), enacted by the Sangguniang Bayan per Appropriation Ordinance No. 08, Series of 2025;

RESOLVED FURTHERMORE, the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the municipal government and that compliance with the existing laws, rules and regulations shall be the responsibility of the municipality.
