RESOLUTION APPROVING RESOLUTION NO. 256-2025 OF THE MUNICIPALITY OF VALLADOLID, NEGROS OCCIDENTAL, ADOPTING THE UPDATED MUNICIPAL ORGANIZATIONAL STRUCTURE OF THE MUNICIPAL GOVERNMENT OF VALLADOLID FOR CY 2026

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 256-2025 of the Municipality of Valladolid, Negros Occidental, adopting the Updated Municipal Organizational Structure of the Municipal Government of Valladolid for CY 2026;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject resolution reveals that the same is within the power of the Sangguniang Bayan of the Municipality of Valladolid to enact and pursuant to Section 76, Section 16 and Section 447(a)(2)(i) of R.A. 7160, otherwise known as the Local Government Code of 1991, subject to compliance with applicable Civil Service Commission rules and budgeting and accounting laws;

WHEREAS, in view of the foregoing, the SP Committee on Human Resource recommends approval of the same;


