RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE DATA SHARING AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PHILIPPINE STATISTICS AUTHORITY AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE SHARING AND PROCESSING OF DATA COLLECTED THROUGH THE COMMUNITY-BASED MONITORING SYSTEM (CBMS) AND RELATED SURVEYS TO SUPPORT LOCAL GOVERNANCE, PLANNING AND DEVELOPMENT PROGRAMS

WHEREAS, the request from Governor Eugenio Jose "Bong" Lacson, dated January 15, 2026, has been forwarded to the Sangguniang Panlalawigan seeking authority to sign the Data Sharing Agreement to be entered into by and between the Philippine Statistics Authority and the Province of Negros Occidental;

WHEREAS, the Province of Negros Occidental intends to enter into the said Data Sharing Agreement for the purpose of facilitating the lawful sharing and processing of data collected through the Community-Based Monitoring System (CBMS) and related surveys to support local governance, development planning, and the implementation of programs and projects;

WHEREAS, the agreement contains provisions to safeguard personal and sensitive information, and to ensure compliance with relevant laws and regulations;

This resolution shall take effect immediately upon approval.


