RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE ST. SCHOLASTICA'S BACOLOD ALUMNAE FOUNDATION, INC. RELATIVE TO THE GRANT OF FINANCIAL ASSISTANCE THAT WILL BE EXTENDED BY THE PROVINCE TO THE SAID FOUNDATION IN THE AMOUNT OF TWO MILLION TWO HUNDRED THOUSAND PESOS (₱2,200,000.00) FOR THEIR PROJECT, ENTITLED: "FINANCIAL ASSISTANCE FOR ALOHA MEDICAL MISSION 2026"

WHEREAS, thereby presented to the Board for review and appropriate action of the Sangguniang Panlalawigan of Negros Occidental is the request of the Provincial Governor for authority to sign, for and in behalf of the Province, the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and the St. Scholastica's Bacolod Alumnae Foundation, Inc. relative to the grant of financial assistance that will be extended by the Province to the said foundation in the amount of Two Million Two Hundred Thousand Pesos for their project, entitled: "Financial Assistance for the Aloha Medical Mission 2026" in partnership with the Province of Negros Occidental, to be conducted in Valladolid District Hospital;

WHEREAS, subject agreement is consistent with the powers and functions of the Province of Negros Occidental under Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, which authorizes local government units to promote the general

welfare, including the provision of basic health services and medical assistance to indigent constituents;

WHEREAS, the grant of financial assistance to a duly accredited non-government organization for the conduct of a medical mission falls within the Province mandate to promote public health and social services;

WHEREAS, in view of the foregoing, finding the subject matter to be in order, the SP Committee on Health recommends approval of the same;

NOW THEREFORE, on motion of Hon. Araceli T. Somosa, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to authorize the Provincial Governor to sign, for and in behalf of the Province, the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and the St. Scholastica's Bacolod Alumnae Foundation, Inc. relative to the grant of financial assistance that will be extended by the Province to the said foundation in the amount of Two Million Two Hundred Thousand Pesos (₱2,200,000.00) for their project, entitled: "Financial Assistance for the Aloha Medical Mission 2026".

This resolution shall take effect immediately upon approval.


