RESOLUTION APPROVING THE CONTRACT OF SERVICES TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND MR. ROMEO T. GAMILLA RELATIVE TO THE ENGAGEMENT OF HIS SERVICES AS ACCOMPANIST/COLLABORATING ARTIST FOR THE NEGROS OCCIDENTAL SINGING AMBASSADORS (NOSA) FOR JANUARY 1, 2026 – DECEMBER 31, 2026

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Governor for the approval and authority to sign the Contract of Services to be entered into by and between the Province of Negros Occidental and Mr. Romeo T. Gamilla relative to the engagement of his services as Accompanist/Collaborating Artist for the Negros Occidental Singing Ambassadors (NOSA) for the period of January 1, 2026 – December 31, 2026;

WHEREAS, the contract clearly defines the scope of services, including rehearsals, performances, artistic planning, auditioning and evaluation of members, and related musical responsibilities necessary for the effective operation and continued excellence of NOSA;

WHEREAS, Mr. Gamilla shall receive a monthly honorarium in the amount of Eighteen Thousand Two Hundred Fifty One Pesos (P18,251.00) as professional fee subject to imposable deductions and /or taxes prescribed by applicable laws, rules and regulations;




