WHEREAS, thereby presented to the Board for review and appropriate action is Resolution No. 2025-182 of the Municipality of Calatrava, Negros Occidental, concurring and approving Municipal Development Council Resolution No. 3, Series of 2025, entitled: "Resolution Adopting the FY 2026 Annual Investment Program";

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

WHEREAS, a review of the said ordinance shows that the same is in accord with the provisions under Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandating Local Government Units to formulate their local development plans/programs/projects/activities based on their respective thrusts/priorities;

NOW, THEREFORE, on motion of Hon. Araceli T. Somosa and unanimously seconded by all the members present,


