RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 04, SERIES OF 2025 OF THE MUNICIPALITY OF ISABELA, NEGROS OCCIDENTAL, COVERING THE FY 2025 SUPPLEMENTAL BUDGET NO. 3 OF THE SAID MUNICIPALITY IN THE AMOUNT OF TEN MILLION FOUR HUNDRED FORTY FIVE THOUSAND TWO HUNDRED FORTY EIGHT PESOS AND SEVENTY FOUR CENTAVOS (P10,445,248.74)

WHEREAS, thereby presented to the Board for review and appropriate action is the FY 2025 General Fund Supplemental Budget No. 3 of the Municipality of Isabela, Negros Occidental with a total appropriation of Ten Million Four Hundred Forty Five Thousand Two Hundred Forty Eight Pesos and Seventy Four Centavos (P10,445,248.74), enacted by the Sangguniang Bayan per Appropriation Ordinance No. 04, Series of 2025;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 Edition, implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve and declare operative in its entirety effective December 3, 2025, the Appropriation Ordinance No. 04, Series of 2025 of the Municipality of Isabela, Negros Occidental, subject to the posting requirement under Section 59 of the Local Government Code, and further subject to the following conditions:

1. The utilization of the 20% Development Fund shall be disbursed in accordance with the general policies prescribed under Joint Memorandum Circular No. 1 of the Department of Budget and Management (DBM), Department of Finance (DOF) and Department of Interior and Local Government (DILG) dated November 4, 2020 and shall proceed from itemized appropriations for specific development projects/activities embodied in the Local Development Plan and/or public investment program formulated and prioritized by the Local Development Council and approved by the Sangguniang Panlungsod as provided under Section 454(d) of the Implementing Rules and Regulations (IRR) of Republic Act No. 7160.

RESOLVED FURTHER, that this Resolution does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

RESOLVED FURTHERMORE, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
