RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 06, SERIES OF 2025 OF THE MUNICIPALITY OF TOBOSO, NEGROS OCCIDENTAL APPROVING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 5 OF THE SAID MUNICIPALITY IN THE AMOUNT OF NINE MILLION ONE HUNDRED ONE THOUSAND SIX HUNDRED SEVENTY TWO PESOS AND SIXTY CENTAVOS (P9,101,672.60)

WHEREAS, thereby presented to the Board for review and appropriate action is the Appropriation Ordinance No. 6, series of 2025 of the Municipality of Toboso, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 5 of the said municipality in the total amount of Nine Million One Hundred One Thousand Six Hundred Seventy Two Pesos and Sixty Centavos (P9,101,672.60) that was submitted to the Sangguniang Panlalawigan for review on November 24, 2025;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 edition and implementing circulars and other issuances as pre-reviewed and endorsed by the Local Finance Committee through the Provincial Budget Office;

NOW, THEREFORE, on motion of Hon. Araceli T. Somosa and unanimously seconded by all members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 6, series of 2025 of the Municipality of Toboso, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 5 of the said municipality in the total amount of Nine Million One Hundred One Thousand Six Hundred Seventy Two Pesos and Sixty Centavos (P9,101,672.60) subject to the posting requirement under Section 59 of the Local Government Code and that the appropriation for Donations shall be spent solely for public purpose pursuant to Sections 305 (b), 335 and 351 of the Local Government Code;

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with the existing laws, rules and regulations shall be the responsibility of the city government.
