THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve and declare operative in its entirety effective December 16, 2025, the Appropriation Ordinance No. 2025-07 of the City of Escalante, Negros Occidental, entitled: "AN ORDINANCE TO APPROPRIATE FIFTEEN MILLION EIGHT HUNDRED NINETY THOUSAND PESOS (Php15,890,000.00) GENERAL FUND, COVERING SUPPLEMENTAL BUDGET NO. 5, CY 2025, FOR THE EXPENDITURES ENUMERATED HEREIN", subject to posting requirement under Section 59 of the Local Government Code and subject to the condition that the grant of Collective Negotiation Agreement (CNA) Incentive for FY 2025 shall be subject to the guidelines of Budget Circular No. 2025-2 dated November 19, 2025 of the Department of Budget and Management;
