
RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE PRO-FORMA MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE DIFFERENT LOCAL GOVERNMENT UNITS OF THE PROVINCE RELATIVE TO THE INSTALLATION, OPERATION AND MAINTENANCE OF A RADIO REPEATER TO SUPPORT THE PROVINCIAL FOR DISASTER RISK REDUCTION MANAGEMENT EMERGENCY COMMUNICATIONS NETWORK

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Pro-Forma Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and the different Local Government Units of the province relative to the installation, operation and maintenance of a radio repeater to support the Provincial for Disaster Risk Reduction Management Emergency Communications Network;



This resolution shall take effect immediately upon approval.


