RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 4, SERIES OF 2025 OF THE MUNICIPALITY OF EB MAGALONA, NEGROS OCCIDENTAL APPROVING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 4 OF THE SAID MUNICIPALITY IN THE AMOUNT OF THREE MILLION SEVEN HUNDRED SEVENTY FIVE THOUSAND THREE HUNDRED FIFTY THREE AND THIRTY CENTAVOS (P3,775,353.30)

WHEREAS, thereby presented to the Board for review and appropriate action is the Appropriation Ordinance No. 4, series of 2025 of the Municipality of EB Magalona, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 4 of the said municipality in the total amount of Three Million Seven Hundred Seventy Five Thousand Three Hundred Fifty Three and Thirty Centavos (P3,775,353.30) that was submitted to the Sangguniang Panlalawigan for review on November 24, 2025;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 edition and implementing circulars and other issuances as pre-reviewed and endorsed by the Local Finance Committee through the Provincial Budget Office;


