RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 8, SERIES OF 2025 OF THE MUNICIPALITY OF E.B. MAGALONA, NEGROS OCCIDENTAL, COVERING THE 2025 SUPPLEMENTAL BUDGET NO. 2 OF FOR THE ECONOMIC ENTERPRISE – MARKET, A SPECIAL ACCOUNT UNDER THE GENERAL FUND OF THE SAID MUNICIPALITY IN THE AMOUNT OF FOUR THREE HUNDRED FORTY TWO THOUSAND NINE HUNDRED FIFTY NINE PESOS AND THIRTY EIGHT CENTAVOS (P342,959.38)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2025 Supplemental Budget No. 2 of the Economic Enterprise – Market, a special account under the General Fund of the Municipality of E.B. Magalona, Negros Occidental with an appropriation of P342,959.38 enacted by the Sanggunian Bayan per Appropriation Ordinance No. 8, series of 2025;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 8, series of 2025 of the Municipality of E.B. Magalona covering the 2025 Supplemental Budget No. 2 of the Economic Enterprise – Market, a special account under the General Fund of the said municipality with an appropriation of P342,959.38 and considered operative in its entirety subject to the posting requirement under Section 59 of LGC 1991 and subject further to the condition and reminder:

1. the grant of Productivity Enhancement Incentive (PEI) shall be in accordance with the provisions of Circular Letter No. 2025-13 dated December 17, 2025 of the DBM; and
2. strictly adhere to the period of submission of Appropriation Ordinances to the Sangguniang Panlalawigan for review per Section 56(a) of RA 7160 which states that: "Review of Component Cities and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan - (a) within three (3) days after approval, the Secretary to the Sangguniang Panlungsod or Sangguniang Bayan shall forward to the Sangguniang Panlalawigan for review, copies of approved ordinances and resolutions approving local development plans and public investment programs formulated by the local development councils".

RESOLVED FURTHER, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law and that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
