**RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 25-05, SERIES OF 2025 OF THE CITY OF SAN CARLOS, NEGROS OCCIDENTAL APPROVING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 4 OF THE SAID CITY IN THE AMOUNT OF SEVENTEEN MILLION ONE HUNDRED TWENTY EIGHT THOUSAND FOUR HUNDRED EIGHTY FOUR PESOS (P17,128,484.00)**

**WHEREAS**, thereby presented to the Board for review and appropriate action is the Appropriation Ordinance No. 25-05, series of 2025 of the City of San Carlos, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 4 of the said city in the amount of Seventeen Million One Hundred Twenty Eight Thousand Four Hundred Eighty Four Pesos (P17,128,484.00) that was submitted to the Sangguniang Panlalawigan for review on December 17, 2025;

**WHEREAS**, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 edition and implementing circulars and other issuances as pre-reviewed and endorsed by the Local Finance Committee through the Provincial Budget Office;

**WHEREAS**, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

**THE SANGGUNIANG PANLALAWIGAN RESOLVED**, as it hereby resolves, to approve Appropriation Ordinance No. 25-05, series of 2025 of the City of San Carlos, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 4 of the said city in the amount of Seventeen Million One Hundred Twenty Eight Thousand Four Hundred Eighty Four Pesos (P17,128,484.00) subject to the posting requirement under Section 59 of the Local Government Code of 1991 and subject further to the following conditions and reminder:

1. The grant of Performance Based Bonus (PBB) shall strictly be in accordance with the provisions of Joint Memorandum Circular (JMC) No. 2025-001 dated April 30, 2025 and JMC No. 2025-002 dated June 27, 2025 of the Department of Interior and Local Government (DILG) and the Department of Budget and Management (DBM); and Regional Memorandum of the DILG – Negros Island Region dated October 28, 2025. Amount of the PBB shall be consistent with the rate prescribed in the Notice of Eligibility (NOE) granted to the LGU dated October 30, 2025, which state that: LGU Officials and employees are consequently eligible for a maximum rate of 100% of each individual's 20% monthly basic salary (MBS) as of December 31, 2023, with isolation of the unit/s and official/s primarily accountable for the deficiency;"
2. The Local Chief Executive (LCE), upon approving the AO, shall sign in every page thereof pursuant to Section 54(a) of the LGC, which provides that, "every ordinance enacted by the Sangguniang Panlalawigan, Sangguniang Panlungsod, or Sangguniang Bayan shall be presented to the provincial governor or city municipal mayor, as the case may be. If the LCE concerned approves the same, he shall affix his signature on each and every page thereof...xxx."

**RESOLVED FURTHER**, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with the existing laws, rules and regulations shall be the responsibility of the city government.

**ADOPTED UNANIMOUSLY.**

This resolution shall take effect immediately upon approval.
