RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 11, SERIES OF 2025 OF THE CITY OF SILAY, NEGROS OCCIDENTAL APPROVING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 8 OF THE SAID CITY IN THE AMOUNT OF SEVENTY FIVE MILLION SEVEN HUNDRED THIRTY THOUSAND ONE HUNDRED EIGHTY THREE PESOS AND NINETY TWO CENTAVOS (P75,730,183.92)

WHEREAS, thereby presented to the Board for review and appropriate action is the Appropriation Ordinance No. 11, series of 2025 of the City of Silay, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 8 of the said city in the total amount of Seventy Five Million Seven Hundred Thirty Thousand One Hundred Eighty Three Pesos and Ninety Two Centavos (P75,730,183.92) that was submitted to the Sangguniang Panlalawigan for review on December 26, 2025;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 edition and implementing circulars and other issuances as pre-reviewed and endorsed by the Local Finance Committee through the Provincial Budget Office;

NOW, THEREFORE, on motion of Hon. Andrew Gerard L. Montelibano and unanimously seconded by all members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 11, series of 2025 of the City of Silay, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 8 of the said city in the total amount of Seventy Five Million Seven Hundred Thirty Thousand One Hundred Eighty Three Pesos and Ninety Two Centavos (P75,730,183.92) subject to the posting requirement under Section 59 of the Local Government Code and to the condition that the disbursement of the appropriation for Other Personnel Benefits shall strictly be in accordance with the existing laws/issuances on specific other personal benefits issued by the Office of the President and the Department of Budget and Management. Moreover, the local government unit is encouraged to indicate the AIP reference codes under column three of Local Budget Preparation Form 9 (Statement of Supplemental Appropriation).

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with the existing laws, rules and regulations shall be the responsibility of the city government.
