RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-07, SERIES OF 2025 OF THE CITY OF CADIZ, NEGROS OCCIDENTAL ENTITLED: "AN ORDINANCE APPROPRIATING FIFTY FOUR MILLION TWO HUNDRED THOUSAND PESOS (P54,200,000.00) AS GENERAL FUND SUPPLEMENTAL BUDGET NO. 5 OF THE CITY OF CADIZ FOR FISCAL YEAR 2025"

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is Appropriation Ordinance No. 2025-07, Series of 2025 of the City of Cadiz, Negros Occidental entitled: "AN ORDINANCE APPROPRIATING FIFTY FOUR MILLION TWO HUNDRED THOUSAND PESOS (P54,200,000.00) AS GENERAL FUND SUPPLEMENTAL BUDGET NO. 5 OF THE CITY OF CADIZ FOR FISCAL YEAR 2025";

WHEREAS, the same shows apparent compliance with the same law, its Implementing Rules and Regulations, CY 2023 Budget Operations Manual for Local Government Unit and implementing circulars and other issuances;

WHEREAS, it is recommended for approval and considered operative in its entirety effective December 19, 2025 subject to the posting requirements under Section 59 of LGC and to the following conditions and reminders, to wit:

1. *The items for Donations shall be spent solely for public purpose pursuant to Section 305(b), 335 and 351 of LGC 1991. Furthermore, disbursement of Donations under the offices/s other than the Mayor's office shall be under the general supervision of the Local Chief Executive per Section 455 of the 1991 LGC;*
2. *The grant of Service Recognition Incentive (SRI) shall be in accordance with the provisions of Budget Circular No. 2025-3, dated December 5, 2025 of the DBM;*
3. *The grant of the Gratuity pay to Contract of Service (COS) and Job Order Workers shall be in accordance with the provisions of Budget Circular No. 2025-4 dated December 16, 2025 of the Department of Budget and Management;*
4. *The local government unit is encouraged to indicate the AIP reference codes under column three (3) of Local Budget Preparation Form No. 9 (Statement of Supplemental Appropriation). The code assigned to each PPA facilitates validation of whether or not the PPAs funded in the budget are the same PPAs prioritized in the AIP; and*
5. *That the Local Chief Executive (LCE) upon approving the AO, shall sign in every page thereof pursuant to Section 54(a) of the LGC, which provides that, "every ordinance enacted by the Sangguniang Panlalawigan, Sangguniang Panlungsod, or Sangguniang Bayan shall be presented to the provincial governor or city or municipal mayor, as the case may be. If the LCE concerned approves the same, he shall affix his signature on each and every page thereof...xxx.*

WHEREAS, in view of the foregoing, the SP Committee on Finance, deemed it best to approve the same;

NOW THEREFORE, on motion of Hon. Arthur Christopher D. Marañon, unanimously seconded by all members present;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2025-07, Series of 2025 of the City of Cadiz, Negros Occidental entitled: "AN ORDINANCE APPROPRIATING FIFTY FOUR MILLION TWO HUNDRED THOUSAND PESOS (P54,200,000.00) AS GENERAL FUND SUPPLEMENTAL BUDGET NO. 5 OF THE CITY OF CADIZ FOR FISCAL YEAR 2025";

FURTHER RESOLVED, this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

FINALLY RESOLVED, the accuracy of the statements/certifications and other supporting documents contained in the supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the city government.

This resolution shall take effect immediately upon approval.




