RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-05 OF THE MUNICIPALITY OF HINOBA-AN, NEGROS OCCIDENTAL, COVERING THE FY 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 4 OF THE SAID MUNICIPALITY IN THE AMOUNT OF TEN MILLION SIX HUNDRED THIRTY ONE THOUSAND PESOS (P10,631,000.00)

WHEREAS, thereby presented to the Board for review and appropriate action is the FY 2025 General Fund Supplemental Budget No. 4 of the Municipality of Hinoba-an, Negros Occidental with a total appropriation of Ten Million Six Hundred Thirty One Thousand Pesos (P10,631,000.00), enacted by the Sangguniang Bayan per Appropriation Ordinance No. 2025-05;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 Edition and implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve and declare operative in its entirety effective December 17, 2025, the Appropriation Ordinance No. 2025-05 of the Municipality of Hinoba-an, Negros Occidental, subject to the posting requirement under Section 59 of the Local Government Code (LGC) of 1991, and further subject to the following conditions and reminders:

1. The grant of Collective Negotiation Agreement Incentive (CNAI) for FY 2025 shall be subject to the guidelines of Budget Circular No. 2025-2, dated November 19, 2025 of the Department of Budget and Management;
2. The disbursement of the appropriation for Other Personnel Benefits/Bonuses/Allowances/Incentive shall be strictly be in accordance with the existing laws/issuances on specific other personal benefits issued by the Office of the President and the Department of Budget and Management.

RESOLVED FURTHER, that this Resolution does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

RESOLVED FURTHERMORE, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the municipal government and that compliance with the existing laws, rules and regulations shall be the responsibility of the municipality.


