RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 07, SERIES OF 2025 OF THE CITY OF VICTORIAS, NEGROS OCCIDENTAL, COVERING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 7 OF THE SAID CITY IN THE AMOUNT OF FORTY THREE MILLION SEVEN HUNDRED FIFTY THOUSAND PESOS (P43,750,000.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2025 General Fund Supplemental Budget No. 7 of the City of Victorias, Negros Occidental with a total appropriation of P43,750,000.00, enacted by the Sanggunian Panlungsod per Appropriation Ordinance No. 07, series of 2025;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 07, series of 2025 of the City of Victorias covering the 2025 General Fund Supplemental Budget No. 6 of the said city with a total appropriation of P42,750,000.00 and considered operative in its entirety effective December 12, 2025 subject to the posting requirement under Section 59 of LGC 1991 and subject to the following conditions and reminders:

1. That the grant of 2023 Performance Based Bonus (PBB) shall strictly be in accordance with the provisions of JMC No. 2025-001 dated April 30, 2025 and 2025-002 dated June 27, 2025 of the DILG and DBM, and Regional Memorandum of DILG – Negros Island Region dated October 28, 2025;
2. the grant of Gratuity Pay to COS and JO workers in Government for FY 2025 must be in accordance with the provisions of Budget Circular No. 2025-4 dated December 16, 2025 of the DBM;
3. That the grant of Collective Negotiation Agreement (CNA) Incentive shall be in Accordance with the provisions of Budget Circular No. 2025-2 dated November 19, 2025 of the DBM;

RESOLVED FURTHER, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law and that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the city government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
