RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-006, OF THE MUNICIPALITY OF MOISES PADILLA, NEGROS OCCIDENTAL APPROVING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 5 OF THE SAID MUNICIPALITY IN THE AMOUNT OF ELEVEN MILLION TWO HUNDRED THIRTY THREE THOUSAND PESOS (P11,233,000.00)

WHEREAS, thereby presented to the Board for review and appropriate action is the Appropriation Ordinance No. 2025-006, of the Municipality of Moises Padilla, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 5 of the said municipality in the total amount of Eleven Million Two Hundred Thirty Three Thousand Pesos (P11,233,000.00) that was submitted to the Sangguniang Panlalawigan for review on January 9, 2026;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2025-006, of the Municipality of Moises Padilla, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 5 of the said municipality in the total amount of Eleven Million Two Hundred Thirty Three Thousand Pesos (P11,233,000.00) subject to the posting requirement under Section 59 of the Local Government Code and the condition that the disbursement of the appropriation for Other Personnel Benefits shall strictly be in accordance with the existing laws/issuances on specific other personal benefits issued by the Office of the President and the Department of Budget and Management.
