***RESOLUTION DECLARING ORDINANCE NO. 25-26 OF THE CITY OF SAN CARLOS, NEGROS OCCIDENTAL, ENTITLED: "AMENDATORY ORDINANCE TO ORDINANCE NO. 25-08, GOVERNING THE SAN CARLOS CITY HOSPITAL CONSIGNMENT SYSTEM, PROVIDING VARIOUS REVISIONS THERETO AND FOR OTHER PURPOSES", AS A VALID ENACTED ORDINANCE***

***WHEREAS***, thereby presented to the Board for review and appropriate action is Ordinance No. 25-26 of the City of San Carlos, Negros Occidental, entitled: "AMENDATORY ORDINANCE TO ORDINANCE NO. 25-08, GOVERNING THE SAN CARLOS CITY HOSPITAL CONSIGNMENT SYSTEM, PROVIDING VARIOUS REVISIONS THERETO AND FOR OTHER PURPOSES";

***WHEREAS***, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

***WHEREAS***, a review of the said ordinance reveals that the same is consistent with the provision as stated under Section 458 of Republic Act 7160 otherwise known as the Local Government Code of 1991;

***WHEREAS***, in view of the foregoing, the SP Committee on Health recommends approval of the same,
