**RESOLUTION APPROVING ORDINANCE NO. 01, SERIES OF 2026 OF THE MUNICIPALITY OF ISABELA AUTHORIZING THE MUNICIPAL VICE-MAYOR / PRESIDING OFFICER TO AUGMENT ANY ITEM IN THE APPROVED 2026 ANNUAL BUDGET IN THE OFFICE OF THE SANGGUNIANG BAYAN FROM SAVINGS IN OTHER ITEMS WITHIN THE SAME EXPENSE CLASS PURSUANT TO SECTION 336 OF RA 7160 OTHERWISE KNOWN AS THE 1991 LOCAL GOVERNMENT CODE EFFECTIVE UPON ITS APPROVAL**

*WHEREAS*, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Ordinance No. 01, series of 2026 of the Municipality of Isabela authorizing the Municipal Vice-Mayor / Presiding Officer to augment any item in the approved 2026 Annual Budget in the Office of the Sangguniang Bayan from savings in other items within the same expense class pursuant to Section 336 of RA 7160 otherwise known as the 1991 Local Government Code effective upon its approval;

*WHEREAS*, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

*WHEREAS*, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Bayan of the Isabela to enact pursuant to the provisions of Section 336 of the 1991 Local Government Code;

*WHEREAS*, in view of the foregoing, the SP Committee on Finance recommends approval of the same;
