**RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 25-07 OF THE CITY OF BAGO, NEGROS OCCIDENTAL, COVERING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 7 OF THE SAID CITY IN THE AMOUNT OF THIRTY NINE MILLION SIX HUNDRED SEVENTY THOUSAND THREE HUNDRED EIGHTY PESOS (P39,670,380.00)**

*WHEREAS*, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2025 General Fund Supplemental Budget No. 7 of the City of Bago, Negros Occidental with a total appropriation of P39,670,380.00, enacted by the Sanggunian Panlungsod per Appropriation Ordinance No. 25-07;

*WHEREAS*, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

*WHEREAS*, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

**THE SANGGUNIANG PANLALAWIGAN RESOLVED**, as it hereby resolves, to approve Appropriation Ordinance No. 25-07 of the City of Bago covering the 2025 General Fund Supplemental Budget No. 7 of the said city with a total appropriation of P39,670,380.00 and considered operative in its entirety effective November 10, 2025 subject to the posting requirement under Section 59 of LGC 1991 and subject to the following conditions and reminder:

1. That Section 56 in relation to Section 327 of the Local Government Code provides that within three (3) days after approval of the Ordinance authorizing the annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said Ordinance to the appropriate reviewing authority.

**RESOLVED FURTHER**, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law and that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the city government.
