RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 03, SERIES OF 2025 OF THE CITY OF TALISAY, NEGROS OCCIDENTAL APPROVING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 2 OF THE SAID CITY IN THE AMOUNT OF EIGHTEEN MILLION SIX HUNDRED NINETY SIX THOUSAND FIVE HUNDRED FIFTY SEVEN AND FIFTY SIX CENTAVOS (P18,696,557.56)

WHEREAS, thereby presented to the Board for review and appropriate action is the Appropriation Ordinance No. 03, series of 2025 of the City of Talisay, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 2 of the said city in the amount of Eighteen Million Six Hundred Ninety Six Thousand Five Hundred Fifty Seven and Fifty Six Centavos (P18,696,557.56) that was submitted to the Sangguniang Panlalawigan for review on January 16, 2026;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 edition and implementing circulars and other issuances as pre-reviewed and endorsed by the Local Finance Committee through the Provincial Budget Office;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 03, series of 2025 of the City of Talisay, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 2 of the said city in the amount of Eighteen Million Six Hundred Ninety Six Thousand Five Hundred Fifty Seven and Fifty Six Centavos (P18,696,557.56) subject to the posting requirement under Section 59 of the Local Government Code of 1991 and following conditions and reminders:

1. The purchase and specifications of the motor vehicles shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018; Budget Circular (BC) No. 2022-1 dated February 11, 2022 and BC No. 2022-1A dated March 1, 2023, of the Department of Budget and Management (DBM);
2. Strict adherence to the period as to the submission of Appropriation Ordinances to the Sangguniang Panlalawigan for review per Section 56(a) of RA 7160, which states that: "Review of Component City and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan – (a) Within Three (3) days after approval, the secretary to the Sangguniang Panlungsod or Sangguniang Bayan shall forward to the Sangguniang Panlalawigan for review, copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with the existing laws, rules and regulations shall be the responsibility of the city government.


ADOPTED UNANIMOUSLY.
