RESOLUTION APPROVING ORDINANCE NO. 771, SERIES OF 2025 OF THE CITY OF TALISAY TRANSFERRING AND ABOLISHING VARIOUS POSITIONS IN THE DIFFERENT OFFICES OF THE CITY GOVERNMENT OF TALISAY CITY, NEGROS OCCIDENTAL, THEREBY IMPLEMENTING PARTIAL REORGANIZATION OF ITS ORGANIZATIONAL STRUCTURE AND STAFFING PATTERN PURSUANT TO SECTION 76 OF RA 7160 AND RA 6758

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

WHEREAS, City Ordinance No. 771, series of 2025 of the City of Talisay, Negros Occidental transferring and abolishing various positions in the different offices of the city government of Talisay City, Negros Occidental, thereby implementing partial reorganization of its organizational structure and staffing pattern pursuant to Section 76 of RA 7160 and RA 6758 was submitted for review by the City of San Talisay to the Sangguniang Panlalawigan of Negros Occidental;

WHEREAS, after prompt examination by the Provincial Legal Office, it is the recommendation of the said Office that the subject Ordinance is within the conferred power of the Sangguniang Panlungsod of San Carlos to enact, thus, the same may be given due course by the Sangguniang Panlalawigan;

WHEREAS, the enactment of the subject ordinance finds legal basis under Section 76 of the Local Government Code of 1991 (RA 7160), which authorizes Local Government Units to design and implement their organizational structures and staffing patterns, subject to applicable civil service laws, rules, and budgetary limitations, to ensure efficient and effective governance;

WHEREAS, the same also finds legal support in RA No. 6758, otherwise known as the Compensation and Position Classification Act of 1989, which governs the standardization of salaries, position classifications, and compensation structures in government service.

WHEREAS, the positions to be transferred and retained are supported by existing appropriations and reflected in the Annual Budget for Fiscal Year 2026 and consistent with statutory compensation and fiscal requirements;

WHEREAS, in view of the foregoing, the SP Committee on Human Resource, recommends approval of the same;

NOW THEREFORE, on motion of Hon. Araceli T. Somosa and duly seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve City Ordinance No. 771, series of 2025 of the City of Talisay, Negros Occidental transferring and abolishing various positions in the different offices of the city government of Talisay City, Negros Occidental, thereby implementing partial reorganization of its organizational structure and staffing pattern pursuant to Section 76 of RA 7160 and RA 6758.
