RESOLUTION APPROVING CITY ORDINANCE NO. 2026-029 OF THE CITY OF VICTORIAS, NEGROS OCCIDENTAL ENTITLED: "AN ORDINANCE INSTITUTIONALIZING THE CITY CULTURE AND ETHICS OFFICE TO BE THE IMPLEMENTER OF THE VALUE FORMATION WORK ETHICS, MORAL RECOVERY AND INTEGRITY DEVELOPMENT PROGRAM FOR CITY OFFICIALS, BARANGAY OFFICIALS, CONSTITUENTS OF THE 26 BARANGAYS AND EMPLOYEES OF THE CITY GOVERNMENT OF VICTORIAS"

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is City Ordinance no. 2026-029 of the City of Victorias, Negros Occidental entitled: "AN ORDINANCE INSTITUTIONALIZING THE CITY CULTURE AND ETHICS OFFICE TO BE THE IMPLEMENTER OF THE VALUE FORMATION WORK ETHICS, MORAL RECOVERY AND INTEGRITY DEVELOPMENT PROGRAM FOR CITY OFFICIALS, BARANGAY OFFICIALS, CONSTITUENTS OF THE 26 BARANGAYS AND EMPLOYEES OF THE CITY GOVERNMENT OF VICTORIAS";
