**RESOLUTION REQUESTING THE CIVIL AVIATION AUTHORITY OF THE PHILIPPINES (CAAP) TO HOLD IN ABEYANCE THE IMPLEMENTATION OF THE INCREASE OF OVERNIGHT PARKING FEES AT THE BACOLOD-SILAY INTERNATIONAL AIRPORT FROM TWO HUNDRED PESOS (P200.00) TO SIX HUNDRED PESOS (P600.00) PENDING PROPER PUBLIC CONSULTATION WITH THE STAKEHOLDERS**

**WHEREAS**, the Civil Aviation Authority of the Philippines (CAAP) started implementing this January 2026 the increase in parking fees at the Bacolod-Silay International Airport;

**WHEREAS**, according to the Manager of the Bacolod-Silay International Airport, such increase in airport parking fees was approved by CAAP on April 21, 2025 and simultaneously implemented in all CAAP operated airports nationwide this year;

**WHEREAS**, there are mounting complaints from travellers and motorists coming in and out of the Province of Negros Occidental against the exorbitant increase of overnight parking fees at the said airport, from P200.00 to P600.00;

**WHEREAS**, to address the said concern, the Sangguniang Panlalawigan of Negros Occidental is requesting CAAP to hold in abeyance the said implementation of parking fee increase at the Bacolod-Silay International Airport until a proper public consultation is conducted for the purpose of informing the travellers and motorist and other stakeholders using the parking facilities of the said airport and at the same time explain to the people of Negros Occidental how they came with such amount of increase;
