RESOLUTION APPROVING CITY REVENUE CODE NO. 2025-001 OF THE CITY OF TALISAY, ENTITLED: "THE 2025 REVISED REVENUE CODE OF THE CITY OF TALISAY, NEGROS OCCIDENTAL, PHILIPPINES"

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of Negros Occidental is City Revenue Code No. 2025-001 of the City of Talisay, entitled: "THE 2025 REVISED REVENUE CODE OF THE CITY OF TALISAY, NEGROS OCCIDENTAL, PHILIPPINES";

WHEREAS, the enactment of the Ordinance finds legal basis under Article X, Section 5 of the 1987 Constitution, which empowers local government units to create their own sources of revenue, subject to limitations provided by law;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991 expressly authorizes cities to levy local taxes, fees, and charges, and to adopt a local revenue code through an ordinance enacted by the Sangguniang Panlungsod;

WHEREAS, City Revenue Code No. 2025-001 of the City of Talisay is legally sound and within the power and authority of the Sangguniang Panlungsod to enact, subject to continuing

compliance with statutory limitations, uniformity requirements, and due process safeguards in the implementation of specific tax and revenue measures contained therein;
