WHEREAS, thereby presented for review and appropriate action of Sangguniang Panlalawigan of Negros Occidental is Resolution No. 2025-436 of the City of Bago, entitled: “RESOLUTION APPROVING RESOLUTION NO. 12, SERIES OF 2025 OF THE CITY DEVELOPMENT COUNCIL EXECUTIVE COMMITTEE, BAGO CITY, ENTITLED: “RESOLUTION APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 12 IN THE AMOUNT OF ONE HUNDRED FIFTY THREE MILLION FIVE HUNDRED EIGHTY FOUR THOUSAND SIX HUNDRED FOURTEEN PESOS AND NINETEEN CENTAVOS (P153,584,614.19)”;

panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject resolution reveals that the same is in accord with the provisions under Republic Act 7160 or the Local Government Code of 1991 mandating Local Government Units to formulate their local development plans/programs/projects/activities based on their respective thrusts/priorities;

WHEREAS, the adoption of the Supplemental AIP is essential as it serves as the basis for funding of several programs, projects and activities of the city which shall be supported and implemented through the enactment of a corresponding appropriation ordinance for the ensuing year, as indicated in the city's Sangguniang Panlungsod (SP) Resolution No. 25-436;

WHEREAS, in view of the foregoing, the SP Committee on Finance, finding the same to be in order, deemed it best to approve the same;

NOW THEREFORE, on motion of Hon. Nicholas M. Yulo, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Resolution No. 25-436 of the City of Bago, Negros Occidental, approving Resolution No. 12, Series of 2025 of the City Development Council Executive Committee of Bago City, approving the Supplemental Annual Investment Program (SAIP) No. 12 in the amount of One Hundred Fifty Three Million Five Hundred Eighty Four Thousand Six Hundred Fourteen Pesos And Nineteen Centavos (P153,584,614.19).
