RESOLUTION APPROVING RESOLUTION NO. 2026-032 OF THE MUNICIPALITY OF LA CASTELLANA, NEGROS OCCIDENTAL, APPROVING MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 2026-001. AMENDING THE 2026 ANNUAL INVESTMENT PROGRAM (AIP) OF THE SAID MUNICIPALITY

WHEREAS, therebv presented to the Board for review and appropriate action is Resolution No. 2026-032 of the Municipality of La Castellana, Negros Occidental, approving the Municipal Development Council Resolution No. 2026-001, entitled: Resolution amending the 2025 Annual Investment Program (AIP);
