RESOLUTION APPROVING CITY ORDINANCE NO. 2025-023 OF THE CITY OF SIPALAY AMENDING THE STAFFING PATTERN OF THE CITY GOVERNMENT OF SIPALAY, NEGROS OCCIDENTAL BY CREATING THE POSITION OF PRIVATE SECRETARY II, SG 15 IN THE CITY VICE MAYOR'S OFFICE, PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is City Ordinance No. 2025-023 of the City of Sipalay amending the staffing pattern of the City Government of Sipalay, Negros Occidental by creating the position of Private Secretary II, SG 15 in the City Vice Mayor's Office, providing funds therefor and for other purposes;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Panlungsod of Sipalay to enact pursuant to the provisions of Section 76 of R.A. 7160 otherwise known as the 1991 Local Government Code;

WHEREAS, in view of the foregoing, the SP Committee on Human Resource recommends approval of the same;
