RESOLUTION APPROVING CITY ORDINANCE NO. 2025-022 OF THE CITY OF SIPALAY INSTITUTIONALIZING THE LAKBAYON AND LAKBAYAN PROJECT OF THE LOCAL GOVERNMENT OF SIPALAY FOR BARANGAY COUNCIL FOR WOMEN, OF THE SAID CITY AND OTHER VULNERABLE SECTORS IN THE COMMUNITY AND ESTABLISH GUIDELINES FOR ITS PROPER IMPLEMENTATION AND OTHER PURPOSES

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is City Ordinance No. 2025-022 of the City of Sipalay institutionalizing the Lakbayon and Lakbayan project of the Local Government of Sipalay for Barangay Council for Women, of the said city and other vulnerable sectors in the community and establish guidelines for its proper implementation and other purposes;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Panlungsod of Sipalay to enact pursuant to the provisions of Section 16 or the General Welfare Clause of the 1991 Local Government Code, as well as Section 36 of Republic Act No. 9710 (Magna Carta of Women);

WHEREAS, in view of the foregoing, the SP Committee on Women recommends approval of the same;
