RESOLUTION APPROVING ORDINANCE NO. 047, SERIES OF 2026 OF THE MUNICIPALITY OF LA CASTELLANA INSTITUTIONALIZING TECHNICAL-VOCATIONAL EDUCATION AND TRAINING (TVET) IN THE MUNICIPALITY OF LA CASTELLANA, PROVIDING FOR ITS STRUCTURE, MANAGEMENT, FUNDING AND FOR OTHER PURPOSES

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Ordinance No. 047, series of 2026 of the Municipality of La Castellana institutionalizing Technical-Vocational Education and Training (TVET) in the Municipality of La Castellana, providing for its structure, management, funding and for other purposes;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Bayan of La Castellana to enact pursuant to the provisions of Section 16 (General Welfare Clause) and Section 17 of R.A. 7160 otherwise known as the 1991 Local Government Code;

WHEREAS, in view of the foregoing, the SP Committee on Education recommends approval of the same;
