RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE MABINI SAMBULONG II FARMERS ASSOCIATION (MASAFA) RELATIVE TO THE FINANCIAL ASSISTANCE THAT WILL BE EXTENDED BY THE PROVINCE FOR THEIR PROJECT ENTITLED: BUGASAN SANG MAMUMUGON PROJECT IN THE AMOUNT OF ONE HUNDRED THOUSAND PESOS (P100,000.00) TO BE TAKEN FROM THE 2025 GAD FUND

This resolution shall take effect immediately upon approval.


