***RESOLUTION APPROVING/CONCURRING WITH RESOLUTION NO. 17, SERIES OF 2025 OF THE PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL OF THE PROVINCE OF NEGROS OCCIDENTAL, ENTITLED: "A RESOLUTION RECOMMENDING THE EXTENSION OF THE DECLARATION OF THE ENTIRE PROVINCE OF NEGROS OCCIDENTAL UNDER A STATE OF CALAMITY DUE TO THE ONGOING THREATS POSED BY KANLAON VOLCANO"***

***WHEREAS***, thereby presented for review and appropriate action of the Sangguniang Panlalawigan of Negros Occidental is Resolution No. 17, Series of 2025 of the Provincial Disaster Risk Reduction and Management Council, entitled: "A RESOLUTION RECOMMENDING THE EXTENSION OF THE DECLARATION OF THE ENTIRE PROVINCE OF NEGROS OCCIDENTAL UNDER A STATE OF CALAMITY DUE TO THE ONGOING THREATS POSED BY KANLAON VOLCANO";

***WHEREAS***, pursuant to National Disaster Risk Reduction and Management Council (NDRRMC) Memorandum Order No. 60, Series of 2019, which prescribed the revised guidelines for the declaration of a State of Calamity provides that the Local Chief Executive (LCE) upon the issuance of the corresponding resolution by the Local Disaster Risk Reduction and Management Council, may declare a State of Calamity for a duration of one (1) year or less, unless the effects of the disaster are recurring or protracted, in which case the declaration shall be continuing;
