**RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL THROUGH THE TERESITA L. JALANDONI PROVINCIAL HOSPITAL AND LOVEYOURSELF, INC. RELATIVE TO THE AUGMENTATION OF LABORATORY SERVICES AND REFERRAL COORDINATION FOR HIV-RELATED TESTING**

**WHEREAS**, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental through the Teresita L. Jalandoni Provincial Hospital and LoveYourself, Inc. relative to the augmentation of laboratory services and referral coordination for HIV-related testing;

**WHEREAS**, the MOA provides for collaboration between the Teresita L. Jalandoni Provincial Hospital and LoveYourself, Inc. for the proper referral, documentation, transport, processing and management of specimens and laboratory services related to HIV testing (including rHIVda and viral load testing) and the same has a term of one (1) year, automatically renewable unless terminated by both parties;

**WHEREAS**, the Committee on Health, finding the subject agreement to be favorable and all the necessary documents to be in order, deemed it best to approve the same;

This resolution shall take effect immediately upon approval.


