AN ORDINANCE CREATING ONE (1) CASUAL POSITION OF ATTORNEY IV WITH SALARY GRADE (SG) 23 AT THE PROVINCIAL LEGAL OFFICE

BE IT ENACTED, by the Sangguniang Panlalawigan of the Province of Negros Occidental in its regular session duly assembled that:

SECTION 1. CREATION. One (1) casual position of Attorney IV with Salary Grade (SG) 23 is hereby created at the Provincial Legal Office.

SECTION 2. SOURCE OF FUND. – Personal Services (PS) costs/requirements will be appropriated under the 2022 Supplemental Budget and sources from PS Savings of vacant positions from the said office.

SECTION 3. SEPARABILITY CLAUSE. – If for any reason, any provision, section or part of this ordinance is declared not valid by a government agency or a court of competent jurisdiction, such judgment shall not affect the other sections or provisions of this ordinance, which shall continue to be in full force and effect.




SECTION 5. EFFECTIVITY. This Ordinance shall take effect immediately upon approval.
