If for any reason, any provision, section or part of this ordinance is declared not valid by a government agency or a court of competent jurisdiction, such judgment shall not affect the other sections or provisions of this ordinance, which shall continue to be in full force and effect.

Section 5. REPEALING CLAUSE. All ordinances, resolutions, rules and regulations, or parts thereof which are inconsistent with any of the provisions of this ordinance are hereby repealed, amended or modified accordingly.






Section 6. EFFECTIVITY. This Ordinance shall take effect immediately upon approval.


