AN ORDINANCE AUTHORIZING THE AUGMENTATION OF THE TRAVELING AND TRAINING EXPENSES ITEMS UNDER THE OFFICE OF THE GOVERNOR-NEGROS OCCIDENTAL SCHOLARSHIP PROGRAM DIVISION PER SECTION 336 OF RA 7160 AND PURSUANT TO SECTION 11 OF APPROPRIATION ORDINANCE NO. 2021-008, SERIES OF 2021

WHEREAS, Section 11 of Appropriation Ordinance No. 2021-008, Series of 2021, approving the FY 2022 General Fund Annual Budget and the FY 2022 Annual Budget for the Operation of Economic Enterprise Development Department of the of the Province of Negros Occidental states that: Pursuant to Section 336 of RA 7160 otherwise known as the Local Government Code of 1991, the Provincial Governor or the Presiding Officer of the Sangguniang Panlalawigan, by virtue of this ordinance, is hereby authorized to augment any item in the approved annual/supplemental budget for their respective offices from savings in other items within the same expense class of their respective appropriations, except in Traveling Expenses and Training Expenses which shall require subsequent enactment of an Ordinance from the Sangguniang Panlalawigan;

NOW THEREFORE, be it enacted by the Sangguniang Panlalawigan of Negros Occidental in its Regular Session duly assembled that:

SECTION 1. AUGMENTATION. The Training Expenses under the Office of the Governor-Negros Occidental Scholarship Program Division is hereby augmented, to wit:



SECTION 3. REPEALING CLAUSE. – All ordinances, resolutions, rules and regulations, or parts thereof which are inconsistent with any of the provisions of this ordinance are hereby repealed, amended or modified accordingly.

SECTION 4. EFFECTIVITY. – This Ordinance shall take effect immediately upon approval.
