**AN ORDINANCE AMENDING ORDINANCE NO. 2022-014 ENTITLED: AN ORDINANCE CREATING THIRTY SIX (36) REGULAR POSITIONS UNDER THE HOD-TERESITA L. JALANDONI PROVINCIAL HOSPITAL, BY AMENDING THE NEW SALARY RATES OF THE POSITIONS CREATED IN VIEW OF THE ADOPTION OF THE THIRD TRANCHE SALARY SCHEDULE EFFECTIVE JULY 1, 2022 PER RESOLUTION NO. 0636, SERIES OF 2022**


