AN ORDINANCE AMENDING ORDINANCE NO. 2022-015 ENTITLED: “AN ORDINANCE CREATING TWO (2) REGULAR POSITIONS UNDER THE OFFICE OF THE GOVERNOR – INFORMATION AND COMMUNICATIONS TECHNOLOGY DIVISION (ICTD),” BY AMENDING THE NEW SALARY RATES OF THE POSITIONS CREATED IN VIEW OF THE ADOPTION OF THE THIRD TRANCHE SALARY SCHEDULE EFFECTIVE JULY 1, 2022 PER RESOLUTION NO. 0636, SERIES OF 2022

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the request for the amendment of Ordinance No. 2022-01, series of 2022 creating two (2) regular positions under the Office of the Governor – Information and Communications Technology Division (ICTD) that was enacted last September 13, 2022;


