AN ORDINANCE PRESCRIBING FEES ON MAMBUKAL CONVENTION HOTEL AT THE MAMBUKAL RESORT AND WILDLIFE SANCTUARY, THEREBY MODIFYING PROVINCIAL TAX ORDINANCE NO. 2017-001, SERIES OF 2017 AND AMENDING SPECIFIC RATES AS PROVIDED THEREIN

WHEREAS, the Mambukal Convention Hotel which is situated inside the Mambukal Resort is about to begin its operation;

WHEREAS, in its operation, fees/rates need to be fixed and subsisting rates prescribed under Provincial Tax Ordinance No. 2017-001, Series of 2017, require an increase under the Comparative Pricing prepared by the Economic Enterprise Development Department;

NOW THEREFORE, on motion of Hon. Rommel T. Debulgado, duly seconded by Hon. Ryan Milos Romeo M. Gamboa and Hon. Victor B. Javellana,

BE IT ENACTED by the Sangguniang Panlalawigan of Negros Occidental in a Regular Session duly assembled that:

SECTION 1. Title – This ordinance shall be known as the “**AN ORDINANCE PRESCRIBING FEES ON MAMBUKAL CONVENTION HOTEL AT THE MAMBUKAL RESORT AND WILDLIFE SANCTUARY, THEREBY MODIFYING PROVINCIAL TAX ORDINANCE NO. 2017-001, SERIES OF 2017, AND AMENDING SPECIFIC RATES AS PROVIDED THEREIN**”.

SECTION 5. **Venue, Mambukal Food Catering Service Package.** – The package rates for Mambukal Food Catering Services shall include venues such as: Mambukal Resort, Negros Residentces & FTMON Pala-Pala.

SECTION 6. **Discounts.** – Senior Citizens and Persons with Disability (PWD) discount are entitled to 20% discount while Provincial Government Employee of Negros Occidental is entitled to 10% discount. Discounts may be availed upon presentation of the corresponding ID upon which ID numbers shall be properly recorded. Employee's, PWD, and Senior Citizens' discounts shall be availed in the alternative, and not cumulatively.

SECTION 7. **Environmental Fee** – An environmental fee of PhP20.00 is hereby imposed under this ordinance.

SECTION 8. **Repealing/Amendatory Clause** – The provisions of Provincial Tax Ordinance No. 2017-001, Series of 2017, that are inconsistent with the provisions of this Ordinance, are hereby amended/repealed accordingly.

SECTION 9. **Effectivity Clause** – This Ordinance shall take effect after its posting and/or publication in accordance with Section 59 of RA 7160.




