HUMAN IMMUNODEFICIENCY VIRUS (HIV), AND ACQUIRED IMMUNE DEFICIENCY SYNDROME (AIDS) IN ACCORDANCE WITH REPUBLIC ACT NO. 11166, DEFINING ITS FUNCTIONS, APPROPRIATING FUNDS THEREOF, AND FOR OTHER RELATED PURPOSES” has been approved;

WHEREAS, the aforementioned Ordinance is comprehensive in nature, as it clearly establishes the central policy-making body that shall direct and guide the overall direction of the program, and likewise provides for an implementing arm responsible for carrying out all necessary programs, projects, and action plans;

WHEREAS, the Ordinance serves as a rekindling of the Province of Negros Occidental’s past commitment to addressing the HIV and AIDS situation, and reinforces efforts to curb the increasing incidence of cases, particularly among male-to-male patients;

WHEREAS, it is the duty and obligation of the Government, as enshrined in the Constitution, to maintain and adopt a comprehensive health program that shall promote and protect the general welfare of the people;

RESOLVED, AS IT HEREBY RESOLVES, on motion of Hon. Araceli T. Somosa and seconded by Hon. Rita Angela S. Gatuslao, Hon. Sixto Teofilo Roxas V. Guanzon Jr, Hon. Patricia Paula M. Alonso-Valderrama, Hon. Genaro G. Alvarez IV, Hon. Mayvelyn L. Madrid during the regular session of the Sangguniang Panlalawigan of Negros Occidental to pass and approve this Resolution, to wit;


