RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE CORAZON LOCSIN MONTELIBANO MEMORIAL REGIONAL HOSPITAL AND THE PROVINCE OF NEGROS OCCIDENTAL, COVERING THE DIFFERENT DISTRICT HOSPITALS OF THE PROVINCE RELATIVE TO THE ESTABLISHMENT AND IMPLEMENTATION OF CLMMRH'S BLOOD SERVICE NETWORKS
