RESOLUTION GRANTING AUTHORITY TO THE PROVINCIAL TREASURER TO CHARGE AGAINST THE CURRENT BUDGET UNDER THE 2026 SPECIAL PURPOSE APPROPRIATIONS – TERMINAL LEAVE BENEFIT ACCOUNT THE UNPAID TERMINAL LEAVE PAY OF THE VARIOUS PROVINCIAL HEALTH OFFICE PERSONNEL IN THE TOTAL AMOUNT OF ONE MILLION THREE HUNDRED NINETY THREE THOUSAND SIX HUNDRED TWENTY SIX PESOS AND FIFTY NINE CENTAVOS (P1,393,626.59)

This resolution shall take effect immediately upon approval.


