RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2025-03 OF THE MUNICIPALITY OF LA CASTELLANA, NEGROS OCCIDENTAL, COVERING THE FY 2025 SUPPLEMENTAL BUDGET NO. 3, OF THE SAID MUNICIPALITY IN THE AMOUNT OF TEN MILLION PESOS (₱10,000,000.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the FY 2025 Supplemental Budget No. 3 of the Municipality of La Castellana, Negros Occidental, amounting to Ten Million Pesos (₱10,000,000.00), enacted by the Sangguniang Bayan per Appropriation Ordinance No. 2025-03;

WHEREAS, the above-mentioned budget shows apparent compliance with the same law, its Implementing Rules and Regulations, Budget Operations Manual, 2023 Edition for Local Government Units, implementing circulars and other issuances;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

NOW THEREFORE, on motion of Hon. Hadji P. Trojillo, unanimously seconded by all the members present;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve and declare operative in its entirety effective November 26, 2025, the Appropriation Ordinance No. 2025-03 of the Municipality of La Castellana, Negros Occidental, covering the FY 2025 Supplemental Budget No. 3 of the said municipality in the amount of Ten Million Pesos

(P10,000,000.00), subject to the posting requirement under Section 59 of the Local Government Code, and subject to the condition that disbursement of fund shall be made strictly in accordance with the provisions of the Deed of Donations executed between the Office of the President and the Municipality.

RESOLVED FURTHER, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

RESOLVED FURTHERMORE, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
